- BUDGET Draw up a budget of how much you are going to spend on each person/item and stick to it.

 Remember you still have to pay rent/mortgage and utility bills during the festive season so make sure you include these in your budget.

- MAKE A LIST Write a list of presents, groceries, clothing and any other expenses you will have over the Christmas period. Try not to make any impulse buys and REMEMBER TO STICK TO YOUR LIST.
- **AVOID HIGH INTEREST CREDIT** Try to avoid payday loans as interest rates are extremely high. For example borrowing £400 from a high interest lender could accrue interest and fees of £167.70 within 40 days.
- **BE SAVVY** Always research for the best deal on any gifts/ goods before you buy. Online shopping can often offer the best value discounts. You should always check out sites which offer discount vouchers and use comparison websites.
- NEW YEAR RESOLUTION Start planning for next Christmas by drawing up a budget for the year ahead to include saving for Christmas.
